

## HOST FAMILY PERMISSION FOR SECURITY CLEARANCE & CRIMINAL BACKGROUND CHECK

If this form contains light blue fields they enable typing the form on-line for convenience but do not allow submitting on-line. You must still print out for signing and completing check boxes and fill-in circles that are not in blue.

This form is kept in a locked drawer separate from other materials to keep social security & other ID numbers private and to record data needed by PEACE but is confidential from sending family, international representative, exchange student, sending schools or host schools. It may be provided on demand by law enforcement or regulatory agencies.

U.S.Department of State(DOS) Regulation 22 CFR 62.25(k)(7) requires sponsor programs to "Verify that each host family household member eighteen years of age and older and any program representatives interacting with students has undergone a criminal background check". The search agency cannot examine public records without the social security number and date of birth of the person(s) begin checked.
